

## Mission of Love Privacy Policy

Mission of Love is a philanthropic voluntary organisation. This privacy policy will explain how our organisation uses the personal data we collect from you.

### What data do we collect?

Our Organisation collects the following data:

- 1) Personal identifying information (Name, address, email address, phone number and any other data you may supply us with)
- 2) Information about your computer and your visits to our website such as your IP address, geographical location, browser type, referral source, length of visit and number of page views.

### How do we collect data?

We collect data and process such data when you:

- 1) Visit our website which uses cookies
- 2) Register on our website contact form, send us an email or contact us in any other way.
- 3) Make a donation via PayPal, Bank transfer or other means.

### How will we use your data?

Mission of Love collects your data so that we can:

- 1) Send you information about our charity including the sponsorship programme and other needs as they may arise.
- 2) Send you communication about or from your sponsored child(ren).
- 3) Use data collected through cookies in the administration of the website and to improve the website's usability. We may also use that information to recognise your computer when you visit our website, and to personalise your experience thereof. Personal Data will be processed lawfully, fairly and transparently. It will be collected for a specific purpose and will be processed accurately. It will not be kept longer than necessary and the integrity and confidentiality of personal data shall be maintained at all times.

Mission of Love will not share your personal data with third parties.

### How do we store your data?

We will take every precaution to prevent the loss, misuse or alteration of your personal information. Your personal data is stored only as long as it is necessary to carry out the purpose for which it was collected.

### Marketing

We will not send you any marketing material and neither will you be receiving any marketing material from third parties.

### What are your data protection rights?

You have the right to:

- 1) **Access** your data by requesting a copy of your personal data stored by Mission of Love
- 2) **Rectify** your data should there be inaccurate or incomplete information
- 3) **Erasure** of data under certain conditions
- 4) **Restrict** processing of your data under certain conditions
- 5) **Object** to processing of data under certain conditions
- 6) **Data portability** in order to transfer the data we have collected to another organisation or to you, under certain conditions.
